The amount of government subsidies provided to energy storage power stations varies significantly depending on the country, region, and specific policies in place. 1. In the United States, federal tax incentives such as the Investment Tax Credit (ITC) significantly boost investment in energy.

These financial perks can help you save hundreds or even thousands of dollars on your battery system, especially when combined with solar panels. In this blog, we'll explore everything you need to know about qualifying for tax credits and rebates when installing a home battery storage. Are there state-level incentives for solar energy storage?

To date, state-level performance incentives for storage have typically been added to solar incentives. Perhaps the best-known state-level storage incentive in the US is California's Self-Generation Incentive Program (SGIP). SGIP provides a dollar per kilowatt (\$/kW) rebate for the energy storage installed.

Which states offer solar storage incentives?

New York (NY-Sun Program) New York offers storage incentives through the NY-Sun initiative, helping reduce battery system costs by thousands of dollars. Massachusetts (SMART Program) Solar Massachusetts Renewable Target (SMART) offers extra incentives for solar-plus-storage systems. Even if your state doesn't offer much, your local utility might.

What is the best incentive for solar storage?

The best incentive for storage is the federal investment tax credit (ITC). The exact same ITC that provides a 30 percent credit on the cost of your solar system provides that same benefit to storage systems under certain conditions.

What incentives are available for energy storage systems?

The Self-Generation Incentive Program (SGIP) offers cash rebates for installing energy storage systems. Rebates can go as high as \$1,000 per kWh for low-income or high-fire-risk areas. New York (NY-Sun Program) New York offers storage incentives through the NY-Sun initiative, helping reduce battery system costs by thousands of dollars.

Are solar storage systems eligible for a 30 percent credit?

The exact same ITC that provides a 30 percent credit on the cost of your solar system provides that same benefit to storage systems under certain conditions. Due to the Inflation Reduction Act, as of 2023, all residential storage systems over 3 kilowatt-hours (kWh) in size are eligible for the ITC.

How do solar incentives work?

These incentives typically take one of two forms: an upfront rebate or a performance-based incentive. Rebate programs are exactly what they sound like: states provide a direct cash payment after your battery is installed and connected to the grid. To date, state-level performance incentives for storage have typically been added to solar incentives.
