# **Luxembourg's latest policy on new energy storage**

With a 20-point roadmap to scale electricity storage, the Grand Duchy is opening doors for innovation in grid flexibility, home energy systems, and smart infrastructure. The strategy, announced on 9 July, aims to maximise the added value of storage batteries for end consumers and the electricity.

On Wednesday 9 July 2025, Luxembourg's Minister of the Economy, SMEs, Energy and Tourism, Lex Delles, presented the strategic roadmap for the promotion and development of electricity storage batteries in Luxembourg: "Späicherstrategie Lëtzebuerg". This strategy outlines the role of storage.

Luxembourg's integrated national energy and climate plan (PNEC) is an important element of the Grand Duchy's climate and energy policy. It sets out the national climate and energy objectives for 2030, as well as the policies and measures needed to achieve them. The measures apply to six sectors.

Luxembourg is targeting a sharp reduction in emissions by 2030, but new measures are needed to boost investment in renewables and energy. What are Luxembourg's Energy Policy Priorities?

Since the 2014 IEA review of Luxembourg's energy policies, the country has made progress on its energy sector priorities of ensuring security of supply, promoting energy efficiency, increasing the use of renewable energy and reducing greenhouse gas (GHG) emissions.

Does Luxembourg need a new electricity infrastructure?

Luxembourg aims to cover over a third of 2030 electricity demand with renewables, mostly through variable renewable energy (VRE) from PV and wind generation. The share of VRE generation in imported electricity is also expected to increase significantly. Taken together, these factors will require substantial investment in electricity infrastructure.

What are Luxembourg's priorities for achieving the necp objectives?

The following are some of the priorities for achieving the objectives set out in Luxembourg's Integrated National Energy and Climate Plan (NECP): Self-consumption and sharing of renewable electricity. Targeted expansion of heat produced by renewable energy: heat pumps will become standard in new and renovated buildings.

How does the Benelux/NSEC benefit Luxembourg?

The Benelux/NSEC provides Luxembourg with access to the sea (in a manner of speaking) and to offshore wind energy. The European Commission has estimated that offshore wind in the North Sea could supply up to 12% of the EU's electricity consumption by 2030.

How will Luxembourg benefit from the European financing mechanism?

In addition to these bilateral or multilateral initiatives, Luxembourg also intends to make full use of the European Financing Mechanism, which allows European countries to join together to develop and finance renewable energy projects, from which the money will be invested in concrete and clearly identifiable projects for Luxembourg taxpayers.
