Electricity consumption in Equatorial Guinea in 2015 was 36 kilotonnes of oil equivalent (ktoe). The country produces all of the energy it consumes. As of 2012, renewable energy accounted for 29.2% of the final energy mix.

What is the legal system in Equatorial Guinea?

Legal System and Judicial Independence Equatorial Guinea's legal system is a mix of civil and customary law. Law No. 7/1992 states that disputes that

cannot be resolved through direct negotiation by the involved parties shall be referred to Equatoguinean courts. Either party can also submit the dispute to international arbitration.
